In consideration for permission to voluntarily participate in tournaments, events, programs and related activities conducted by Shootout Fishing League for any and/or all events in the 2021 season by only signing once, I acknowledge, appreciate and agree that:

1. The risk of injury, disability, death, loss or damage to my person or property from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I have been advised by Shootout Fishing League, and have had the opportunity to seek legal counsel with respect to the legal effect of this document; and,
3. I KNOWINGLY AND FREELY ASSUME ALL RISKS REFERRED TO ABOVE, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF Shootout Fishing League, ITS OFFICERS, OFFICIALS, DIRECTORS, SHAREHOLDERS, AGENTS, AND/OR EMPLOYEES, OTHER PARTICIPANTS, AND SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND, IF APPLICABLE, OWNERS AND LESSORS OF PREMISES AND PROPERTY USED TO CONDUCT THE EVENT (“RELEASEES”) OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR RISKS ARISING FROM MY PARTICIPATION; AND,
4. I agree to monitor weather and water conditions during my participation and assume full responsibility to remove myself from hazards that may arise; and,

7. I agree to submit to a truth verification test administered by Shootout Fishing League and understand that failure to pass the examination as determined by Shootout Fishing League will result in disqualification.

I agree that by signing this release of liability at the onset of the 2021 season I am binded by the agreement in full for the 2021 season and all events including championship that I enter to fish. I will abide by the fullness of this document for each and every event that I participate in by signing this agreement once.
